NAME

1. The name of the Society shall be "Kissan Vikas Chamber Punjab" (KVCP)

REGISTERED OFFICE

2. The registered office of the Society shall be situated at Kissan Vikas Chamber Punjab (KVCP), Kalkat Bhawan, Block –C, Aerocity, Airport Road, SAS Nagar – 140306.

AREA OF OPERATION

3. Area of operation of the KVCP will be State of Punjab.

AIMS/OBJECTIVES

4

The Aims/Objectives for which the Society is established are :

1) To create opinion for reorienting the policies of the state/central

Govt./their organizations with a view to keep them focussed on the development of farming and welfare of farmers with an overall interest of development of farming and prosperity if the farmers.

 To create a platform for discussion on the issues confronting farming and farmers and to act a repository of knowledge on matters related to agriculture in Punjab.

3) To seek the removal of obstacles in the rapid growth of agricultural production, marketing, processing and trade both at the national and international level.

 To approach the State/ Central Government to create facilities for agro processing with a view to improve farmers income.

5) To take up any other activity connected with the welfare of the farmers.

5. IN ADDITION TO ABOVE, TO ACHIEVE THE OBJECTIVES MENTIONED AT NO. 4, KVCP WILL TAKE THE FOLLOWING STEPS :

1) Enlist the services of experts and to have at it's disposal expert Advice on the matters relating to the agriculture sector.

2) Propose legislation/policies and other measures and to procure changes or enactments of law, policies and practices effecting

Agriculture sector in particular and rural sector in general.

- 3) Initiate and support legal action on it's own or on behalf of members jointly or severally in all courts established by laws of the Republic of India whether by authorisation by members or on its own initiative, on all matters affecting members of the KVCP.
- 4) To negotiate and enter into any arrangements with Government or Authorities at state or national level or public or private bodies, that may seem conducive to the KVCP objects or any of them and to apply for or obtain from any such Government or Authority all rights, concessions, and privileges which the KVCP may think it desirable to obtain and to carry out exercise and comply with any such arrangements, rights, privileges and concessions.
- 5) To negotiate and enter into arrangements with similarly situated bodies of farmers in different states/regions in India with a view to achieve the objects of the KVCP.
- 6) To subscribe to, become a member of, or otherwise cooperate with any other KVCP whether incorporated or not, whose, objects are altogether or in part similar to those of this Body.
- 7) To institute awards, scholarships, etc., for outstanding work to an individual or organization in any selected sphere, such a policy formulation, research and development, extension, production, value addition, processing and marketing of agricultural produce/products.
- 8) To encourage, assist and extend knowledge and information connected with production, marketing, processing of agricultural produce through lectures, seminars and by holding workshops/conferences.
- . 9) To collect, tabulate and circulate information/ knowledge and statistics of value to Agriculture sector.
 - 10) To nominate delegates and advisers, etc., to represent members at National Conferences held on agriculture related issues.
 - 11) To take all possible steps which may be necessary for promoting, supporting or opposing recommendations or views or conventions at National Conferences and other Panels and Committees.
 - 12) To the same extent as natural person might or could do to accept, receive, acquire, purchase, take on lease, hire, mortgage, loan, gift, grant, legacy bequest, exchange or otherwise from any person, company, KVCP, Government, institution or body whatsoever and to hold all or any part of all movable and immovable property (ies) of all description now and or hereafter.

Vested in or in possession of the KVCP or any rights or privileges necessary or convenient for the purpose of the KVCP on such terms and conditions as may be thought fit or expedient and to have the same mutated in any court of law or office (Civil or criminal revenue, municipal or estate) in the name of the KVCP.

- 13) To invest or deposit the money of the KVCP not immediately required for the purpose of the KVCP in such approved securities as may, from time to time, be determined by the Executive council, "including in any debentures, shares, Government Promissory Notes, Cash Certificates, Bank or other deposits, Annuities, Bonds or otherwise.
- 14) To have legal, financial, secretariat, research and development or any other services as the executive council may decide to achieve the objects mentioned above.
- 15) To achieve the objects which are incidental to or connected with the objects mentioned above and to do all such other lawful things as are incidental or conducive to the attainment of the above objects.

- 1. SHORT TITLE: These rules may be called Rules of "Punjab Kissan Vikas Chamber".
- 2. DEFINITIONS: Under the context otherwise require, the following words

have meanings as given against them : Word Meaning Agriculture Agriculture sector as a whole including field crops, horticulture, dairy, fishery, poultry, piggery, farm forestry and bee-keeping, mushroom etc. The Members The members whose names shall have been duly entered in the Register of Members and who have not ceased to be members by virtue of any of the provisions of these rules. **KVCP** Kissan Vikas Chamber Punjab The Register The Register of Members maintained in terms of these Rules and Regulations. Executive The Governing body of the KVCP elected as per these Council Rules. Patron A person to be appointed by the Executive Council by consensus. Initially Dr. G.S. Kalkat, Chairman, Punjab State Farmers Commission shall be Patron of KVCP. President. The President/ Vice President/ Secretary General General of the KVCP as appointed from time to time by Vice-President and Secretary Executive Council as per provisions of these rules. General. The Bye-The Bye-Laws as existing from time to time and framed Laws in accordance to these Rules and or as framed and varied by the Executive Council under the power contained in these Rules. The Office The Registered Office, for the time being of the KVCP. Month Calendar month. Financial year commencing from 1st of April ending with Year 31st of March.

3. THE KVCP MAY:

(a) be entitled to affiliate, admit to membership, takeover, aid and to receive aid from any other Society, Association, Firm, Partnership of persons promoting or intending to promote any of the objectives of the KVCP and to subscribe to or aid any such KVCP, Association, Firm, Partnership or Person with a view to obtain any advantage or benefit for the purpose of the KVCP and to subscribe to any fund or any KVCP as may be considered deserving from time to time. 5

- (b) grant emoluments, Contributory Provident Fund, allowances, gratuities and bonuses to the KVCP staff or the dependents of such persons.
- (c) sue or be sued in the name of its President or Secretary.

4. FUNDS

- (a) The KVCP shall raise the funds by way of admission fee of members and their annual subscriptions. The KVCP shall be at liberty to raise/accept funds by way of grants, loans, donations, gifts, advances and any other mode from government, institutions, firms, companies, persons both from India and abroad. The Executive Council shall have the power to accept funds for furthering the objects of the KVCP from any source in any form as is permitted by law.
- (b) The funds and assets of KVCP whensoever derived shall be applied solely towards the promotion of the objects of the KVCP as set forth in these Rules and no portion thereof shall be paid or transferred directly or indirectly by way of dividend, bonus or otherwise by way of profit to persons who at any time are or have been members of the KVCP to any of them provided that nothing herein contained shall prevent the gratuitous distribution among or sale at discount to subscribers of the funds of the KVCP or for any books or publications published by the KVCP or otherwise relating to all or any of its objects as set forth above or the payment in good faith of remuneration to any officers or servant of the KVCP or to any member thereof or other person in return for any services actually rendered to the KVCP.
- (c) True accounts shall be kept of the sums of money received or expended by the KVCP and the matter in respect of which such receipt and expenditure takes place, and' of the property, credits and liabilities of the KVCP and subject to any reasonable restriction as to' time and manner of inspecting the same that may be imposed in accordance with regulations of the KVCP for the time being, shall be

open to the inspection of members. Once at least in every year the accounts of the KVCP shall be examined, and the correctness of the balance sheet ascertained by one or more properly qualified auditor or auditors.

- (d) The KVCP shall be free to borrow or raise money which may be required for the purposes of the KVCP upon bonds, debentures, bills of exchange, promissory notes or other obligations or securities etc. of the KVCP or by mortgage or charge of the KVCP's property and to repay the same.
- (e) The funds of the KVCP shall be deposited in one or more scheduled banks as the Executive Council may decide and such part thereof as shall not be required for current expenses, may at the discretion of the Executive Council, be invested in any investments and such investments shall not be sold or dealt with except at the direction of the Executive Council. The accounts with the banks shall be operated upon by means of cheques signed by the President or the Vice President or by a member of the Executive Council specially authorized in this behalf and countersigned by the Secretary. Any cheque received by the KVCP may be endorsed by the Secretary, the President or the Vice President in favour of the Bank to be credited to the accounts of the KVCP.

5. NUMBER OF MEMBERS

The KVCP for the purpose of registration is declared to consist of an unlimited number of members.

6. MEMBERSHIP

Any person or firm or company from Punjab, professionally engaged in agriculture shall be eligible to apply for membership of the KVCP provided.

- (i) Should have been pursuing agriculture as his/her main source of livelihood.
- (ii) Should assume the responsibilities entailed by membership.

Guidelines relating to membership shall be framed, from time to time, by the Executive Council of the KVCP and it shall also have the powers to alter the criteria for different categories of membership.

Whenever the Council, by resolution, adopted by majority of all its

members present and voting declare that it is in the interest of the KVCP to admit to membership in the KVCP a particular association pursuing the same objects then such Association may be admitted as an institutional member.

7. MEMBERSHIP ADMISSION PROCEDURE

- (a) Admission Fee : A person eligible for admission as a member of the KVCP, shall make an application in writing to the President on the prescribed form, which shall be signed by the applicant and the application shall contain an acceptance of, and an agreement to abide by, the Rules and Regulations of the KVCP as framed by the KVCP. The application shall be accompanied by admission fee as may be decided by the General Body from time to time subject to the minimum of Rs. 1,000/-. The admission fee shall be non refundable but shall be refunded in case the application for admission is rejected.
- (b) All admissions under these Rules, except where expressly otherwise stated, shall be made by an approval of the Executive Council. The President shall notify applicants of their admission or otherwise in such terms as the president may from time to time determine. The President shall also send a copy of these Rules to newly admitted members.
- (c) The Executive Council shall decide any question, which may arise, as to the eligibility or otherwise of a candidate for admission as a member of the KVCP and its decision shall be final and it shall not be bound to assign any reason for its action.
- (d) The Executive Council shall cause to be properly entered in a Register of members, showing the name and address of each registered member, and the membership subscription payable in the current year.

8. SUBSCRIPTION

The annual subscription due from each member shall be as decided by the General Body of the KVCP from time to time subject to the condition that minimum subscription of the member every year shall be Rs.500/-.

9. HONORARY MEMBERS

- Officials and other persons connected with the government, agro Industry, agriculture scientists, agriculture economists, marketing experts or those who have rendered or who have been rendering distinguished service to the interests represented by the KVCP may be admitted Honorary Members by the Council.
- 2. Honorary members shall be entitled to receive the last published

report of the KVCP and to attend and speak, but not to vote, at any meeting held during their membership and may, upon invitation, attend under like conditions any meeting of the KVCP or any of its association, or Sub-Committee.

10. EXPULSION

A majority of three-fourths of the members present in a General Meeting and entitled to vote and voting may, by a resolution, remove from the list of members the name of any member on the grounds enumerated below. Any such person, firm, member, corporation or other body corporate shall, from the passing of such resolution, cease to be a member of the KVCP and cease to have the rights and privileges of membership.

(a) If a member is convicted by a competent Government Authority/Court then the member will become liable to be expelled from the membership during the General Meeting on the recommendation of the Executive Council.

Such member shall be barred from the decision making meetings and, if he is a members of the Council/Committees/Task Forces, he shall be asked to resign from the posts.

- (b) Opportunity will be given to the member concerned to be heard before any action is taken against the member.
- (c) In the event the member is acquitted by a higher Court/Authority then the decision of the Executive Council on the member's re-induction as a member shall be final, upon an application by such member for reinduction.

11. CESSATION OF MEMBERSHIP

A member shall cease to be a member of the KVCP:

- a) in case of death of an individual member and liquidation of KVCP, firm or company.
- b) in case a member defaults for two years in paying his subscription in terms of Rule 8.
- c) in case a member be required by members in General Meeting to resign.
- d) in case a member suffers from any disability, incapacity or disgualification as provided in these Rules.
- e) in case a member breaks the conventions established by the KVCP and circulated to members or act in a manner which is unbecoming of

a member of the KVCP or prejudicial to the interest of the KVCP then the Executive Council would be the final authority to expel the membership of such person after giving such members an opportunity of hearing.

12. VOTING RIGHTS

Every member shall have one vote in the affairs of the KVCP. Honorary members shall not have any voting right.

13. REGISTER OF MEMBERS

A register of members shall be maintained in which shall be entered the name and address and such other information about each member as required by the Executive Council and such register shall be open for inspection by the members at the Registered Office during working hours.

14. EXECUTIVE COUNCIL

- (a) The executive council shall be constituted from out of members of the KVCP.
- (b) The first Executive Council including President/ Vice President shall be nominated by the Chairman of Punjab State Farmers Commission, subsequently the General Body shall elect President and Vice President who will nominate the members of the Executive Council for KVCP giving due representation to the agriculture sector as a whole as under 14 (j).
- (c) The term of the President and Vice President shall be two years from the date they assume the charge. They will not hold same post/office for more than two consecutive terms.
- (d) The term of members of executive council shall be two years, any member shall be eligible for re-selection only for two consecutive terms.
- (e) The total members of the Executive Council shall not exceed 25, not more than two from any one district. More than 50% of the existing members shall constitute the quorum for meetings.
- (f) The general management and control of the KVCP shall be vested in the Executive Council. Meetings of the Executive Council shall be held at least once in three months.

- (g) The Executive Council may exercise all the powers of the KVCP.
- (h) The Executive Council may delegate any of its powers to any Committee/Council, person, employee, branch or body of the KVCP.

- (i) The Executive Council shall be the sole authority for the interpretation of the Rules and of any bye-laws and Regulations that may be made from time to time under the Rules and the decision of the Executive Council upon any question of interpretation or upon any matter affecting the KVCP and not provided for by these Rules or by the said bye-laws and Regulations shall be final and binding on the members.
- (j) The Executive Council shall constitute Sub Committees on :-
 - (i) Field crops
 - (ii) Fruits
 - (iii) Vegetables
 - (iv) Potato
 - (v) Livestock
 - (vi) Dairy
 - (vii) Fishery
 - (viii) Piggery
 - (ix) Bee-keeping
 - (x) Mushroom
 - (xi) Farm Forestry
 - (xii) Any other e.g. Farm Forestry, Post harvest handling etc.
- (k) The Executive Council shall set up the offices, seminar rooms etc. of the KVCP along with required installations/ infrastructure etc.
- (I) The Executive Committee may decide to establish district level Centers of KVCP and frame rules for their functioning.
- 15. The Executive Council shall be the Governing Body of the KVCP and in addition to the powers and authorities by Statute or by these Rules and/or the Bye-laws, if any, expressly conferred upon, it shall exercise all such powers and do all such acts and things as may be exercised or done by the KVCP as the body corporate and which are not by these Rules or the Act and/or by the Byelaws, if any expressly directed to be done by the KVCP in a General Meeting, but subject nevertheless as to such acts and things as are not regulated by the Act or by these Rules and/or the Byelaws, if any, to such regulation or direction as may from time to time be determined upon or given at any Ordinary or Special General Meeting of the KVCP provided that no such regulation or direction shall invalidate any prior act of the Council which would have been valid if the regulation or direction had not been made or given. Any decision of the Council

under these Rules or the Bye-laws, if any, shall be final and binding and no appeal shall lie against such decision. 1

2. Without prejudice to the general powers conferred above, the Executive Council shall have powers:

- (a) To set up or appoint any Sub-Committee or Task Force of the Members of the Council or of the Members of the KVCP and Sub Committee or Task Force for such special purposes on such terms as the Executive Council may determine.
- (b) To delegate, subject to the provisions of the Act, and subject to such conditions as they may think fit, any of their powers to Committee or sub Committee and to make, vary and repeat Bye-laws or Rules for the regulation of the proceedings of the Committees or Sub-Committees.
- (c) To make such Bye-Laws (not being inconsistent with these Rules) from time to time for the management of the KVCP as they shall think proper and from time to time to amend or cancel any Bye-laws, for the time being in force, and to appoint, grant remunerations, take disciplinary action and exercise full control regarding the working of the employees of the KVCP.
- (d) To enter into arrangement upon such terms and subject to such conditions as the Council may deem desirable for working in connection with any Association organized for the protection or development of any farming or rural community with like objects that may apply to be allowed to work in connection with the KVCP provided the objects for which such an Association is or shall be formed are not inconsistent with the objects of the KVCP as defined in these Rules.
- (e) To make such rules or policy as the Executive Council may consider expedient for the regulation of the joint working of any other Association connected with the KVCP or for the purpose of defining terms and conditions of the joint working of such Association or as may from time to time be agreed upon between such Association and the Council.

16. ANNUAL GENERAL MEETING, EXTRAORDINARY GENERAL MEETING

- The Annual General Meeting of the KVCP shall be held once at least in every year at such time in the month of February but not later than 31st March.
- 2. The meetings referred to in the last preceding Rules shall be called

Annual General Meeting. All other general body meetings of the KVCP shall be called Extraordinary General Meetings.

3. The Executive Council may, whenever deem fit, or it shall on the requisition of the holders of not less than 1/5th of the total members of the KVCP forthwith propose to convene an Extraordinary General Meeting of the KVCP provided that the requisition shall be in writing, stating the matters for consideration at the meeting to be called and signed by the members requisitioning the meeting and shall be deposited at the KVCP's office.

17. NOTICE

- 1. Not less than 15 days notice of a General Meeting (including Annual General Meeting) shall be given to the members specifying the place, time and date of the meeting with a statement of the issues to be discussed at the meeting.
- 2. The non-receipt of notice by any of the members shall not invalidate the proceedings at any such meetings.
- 3. Any notice required by these Rules to be given to a member shall be deemed to be sufficiently served if sent by post properly addressed to his last known address. A notice sent by post shall be deemed to have been served at the time when it would have been delivered in the ordinary course of post.

18. PROCEEDINGS AT THE ANNUAL GENERAL MEETING, EXTRAORDINARY GENERAL MEETING

- 1. The business of the Annual General Meeting shall be to receive and consider the annual accounts of the KVCP and the Reports of the Executive Council and of the Auditors, and to transact any business which under these Rules are required to be transacted at Annual General Meetings. All other business transacted at an Annual General Meeting and all business transacted at an Extraordinary General Meeting shall be deemed special. Once in every year, on or before the 14th day succeeding the day on which the Annual General Meeting of the KVCP is held a list shall be filed with the Registrar of Societies, of the names, addresses and occupations of the Executive Council members entrusted with the management of the affairs of the KVCP.
- 2. For all purpose the quorum for an Annual General Meeting and Extraordinary General Meeting shall be one fifth or 100 whichever is less of all members entitled to vote and present in person.
- 3. The President or, in his absence, the Vice President shall take the

chair at the Annual General Meeting or Extraordinary General Meeting of the KVCP or if the President or the Vice President shall not be present within 30 minutes after the time appointed for holding such meeting, the members present shall elect another member as President on show of hands and such President shall be President of the meeting.

- 4. If within half-an-hour from the time appointed for the meeting a quorum be not present, the meeting if convened upon such requisition as provided in rule 19 (2) hereof shall be dissolved but in any other case it shall stand adjourned to the same day in the next week at the same time and place, and if at such adjourned meeting a quorum be not present, those members who are present in person and not being less than 15 shall be a quorum and may discuss the issue for which the previous meeting was called.
- 5. Every question submitted to a meeting shall be decided in the first instance by a show of hands: the President shall declare whether the motion be carried or negative by clear majority, unless a demand for a card vote be made before or immediately after such declaration, the matter shall be determined accordingly. If a card vote be required as aforesaid it shall be taken at once in such manner as the President of the meeting directs unless the meeting shall decide on an adjournment or otherwise for the purpose thereof and the result of the card vote shall be determed to be the resolution of the meeting at which such vote was demanded.
- 6. The President of a General Meeting may adjourn the meeting but no issue shall be discussed at any adjourned meeting other than the issues left un-discussed at the said adjourned meeting.

When a meeting is adjourned for 30 days or more, notice of the adjourned meeting shall be given as in the case of an original meeting. Save as aforesaid it shall not be necessary to give notice of adjournment or of the issues to be discussed at any adjourned meeting.

19. SECRETARY GENERAL & OTHER STAFF

- 1. The Executive Council shall appoint the KVCP's Secretary General initially for five years for running the affairs of the KVCP. He shall be a whole time paid employee of the KVCP.
- Under overall supervision by the executive council, the KVCP's Secretary General shall be the administrative head of the KVCP's permanent staff and Secretariat, who shall sign all documents on

behalf of the KVCP.

 The KVCP shall recruit other supporting staff, technical staff, consultants, members with such designations and at such terms and conditions as the Executive Council of the KVCP may decide. 14

4. The staff of the KVCP shall function under the overall control and superintendence of the Secretary General who may assign such duties to the staff as he/she deems fit.

20. AUDITORS

- 1. The Executive Council shall appoint the auditors of the KVCP. These shall be confirmed at the Annual General Meeting.
- 2. The Accounts of the KVCP shall once at least in every year be audited by the auditors.

21. RECORDS AND DOCUMENTS

- 1. In addition to the Register of Members hereinbefore referred to, the Executive Council shall keep or cause to be kept properly entered up:
 - a) Books of Account showing particulars of all receipts and payments and the assets and liabilities of the KVCP.
 - b) Minutes of meetings of the KVCP, the Executive Council and of any Sub-Committee.
 - c) A register of members of the Executive Council. Records and documents shall be kept at the head office of the KVCP.
- The books of accounts of the KVCP shall be open to inspection by any member at the registered office of the KVCP during such hours as the office of the KVCP remains open on any weak day excluding holidays.

22. OTHER BODIES

The KVCP shall have power, by special resolution to create, form, promote or to join with any other body incorporated or not or in the creation, formation or promotion of any other body whether incorporated or not and whether a branch or subsidiary of the KVCP and to affiliate itself with any such body and may also delegate to it any of its powers. Any power or authority delegated by the KVCP in accordance with the provisions of this Rule may be revoked or cancelled by the KVCP by resolution of the KVCP in General Meeting.

23. AFFILIATED ASSOCIATIONS / INSTITUTIONAL MEMBERSHIP

 Affiliated Association: Any other crop/area specific association of farmers or other organization of agricultural interests shall be eligible for affiliation to the KVCP on such terms and conditions

as the Executive Council may decide. Such affiliation shall not affect the autonomy or independence of the affiliated body, which shall retain the full right to decide and to pursue its own line of action. Such affiliated members shall not have the right to vote.

Institutional Members: Any professional Institutes/Organizations/ Boards, University, education or research institute etc. engaged in the promotion of agricultural interests, dealing with collection and dissemination of information, research and development, technical up gradation process, exploration of new resources, marketing of agricultural produce, supply of credit, insurance or agricultural inputs etc. as distinct from Farmers Associations/ Councils/ Organizations shall be eligible for Institutional Membership of the KVCP on such terms and conditions as the executive council may decide.

b)

Such Institutional Members shall have no power to occupy a seat on the Executive Councils and shall not have the right to vote.

Such arrangements for Affiliation and/or Institutional Membership may be terminated, or reviewed from time to time, by the Executive council, at its sole discretion.

Non-refundable application Fee of Rs. 1000/- shall be enclosed with the application form for Affiliation and/or Institutional Membership. Such an application shall be proposed by one and seconded by another member and may be admitted by the Executive Council.

24. PRESIDENT / VICE PRESIDENT:- The members of the General Body shall elect President and Vice President from amongst themselves, who shall work without any remuneration.

- (a) The President shall have following functions and duties:-
- (i) The President shall preside over all meetings of the Council, and general meetings. He shall preside at the Annual General Meeting, may address the members on such subject as he may deem proper, but such address shall not be taken to represent the views of the KVCP or of the Council unless such representation is expressly indicated.
- (ii) The President shall, also, at any time when he shall deem proper, communicate to the KVCP or to the Council such matters and shall make suggestions as may, in his opinion, tend to promote the prosperity and welfare of members in particular and farmers of Punjab

in general and increase the usefulness of the KVCP and shall perform such other duties as may be incidental to the office of the President. 16

(b) THE VICE PRESIDENT shall have following functions and duties:-

The Vice President, in the absence of the President, shall have the power to perform the duties of the President. In the absence of both the President and the Vice President, the powers and duties of the President shall be exercised and discharged by one of the members of the Council nominated by the President or the Vice President as the case may be or in their absence, by the Executive Council.

25. ALTERATION OF RULES

Rules shall not be altered, varied, modified, remade, rescinded, cancelled, or added to without the sanction of a special Resolution of the General Body KVCP passed by a majority of not less than three-fourths of the votes of the members present and entitled to vote and voting at the meeting at which such resolution is proposed.

26. INDEMNITY

Every member of the Executive Council, the Secretary General and other officers or employees of the KVCP shall be indemnified by the KVCP against all actions done in good faith and in the interest of the KVCP and it shall be the duty of the executive Council to pay all costs, losses and expenses which any such member and the Executive Council, officer or employees of the KVCP may incur or become liable to, by reason of any contract entered into or act or thing properly and lawfully done by him as such member of the Executive Council or officer or servant of the KVCP or in any way in the discharge of his duties out of the funds of the KVCP.

27. DISSOLUTION

(a) The KVCP may be dissolved by a Special General Meeting of the KVCP convened on the recommendation of the Executive Council, or on requisition of not less than three fifths of the members and a meeting to dissolve the KVCP must be composed of not less than three fifths of the members of the KVCP and the resolution upon the dissolution shall not be effective unless passed by majority consisting of three fifths of the votes of the members present and entitled to vote and voting at such Special General Meeting of the KVCP.

(b) The resolution passed under sub-rule (a) hereof may direct that if upon the dissolution of the KVCP there remains after the satisfaction of all debts and liabilities of the KVCP any property whatsoever the same shall not be paid to or distributed amongst the members of the KVCP

but shall be given or transferred to some other KVCP, Institution or institutions having objects similar to the, objects of the KVCP to be determined by the members of the KVCP at the aforesaid Special General Meeting.

(c) If the KVCP shall be insolvent, the liability of the members, who were members on the first day of preceding the commencement of the winding up shall be limited to contributing towards the deficit to the extent of year's annual subscription payable by them and if the same shall be a surplus available for distribution it shall subject to sub-rule (b) of this Rule be shared amongst the members at the date of the commencement of the winding up in the same proportion.

28. RECONSTRUCTION

If the KVCP shall by Special Resolution approve any scheme of reconstruction or amalgamation, the whole or any part of the assets may be transferred accordingly.
